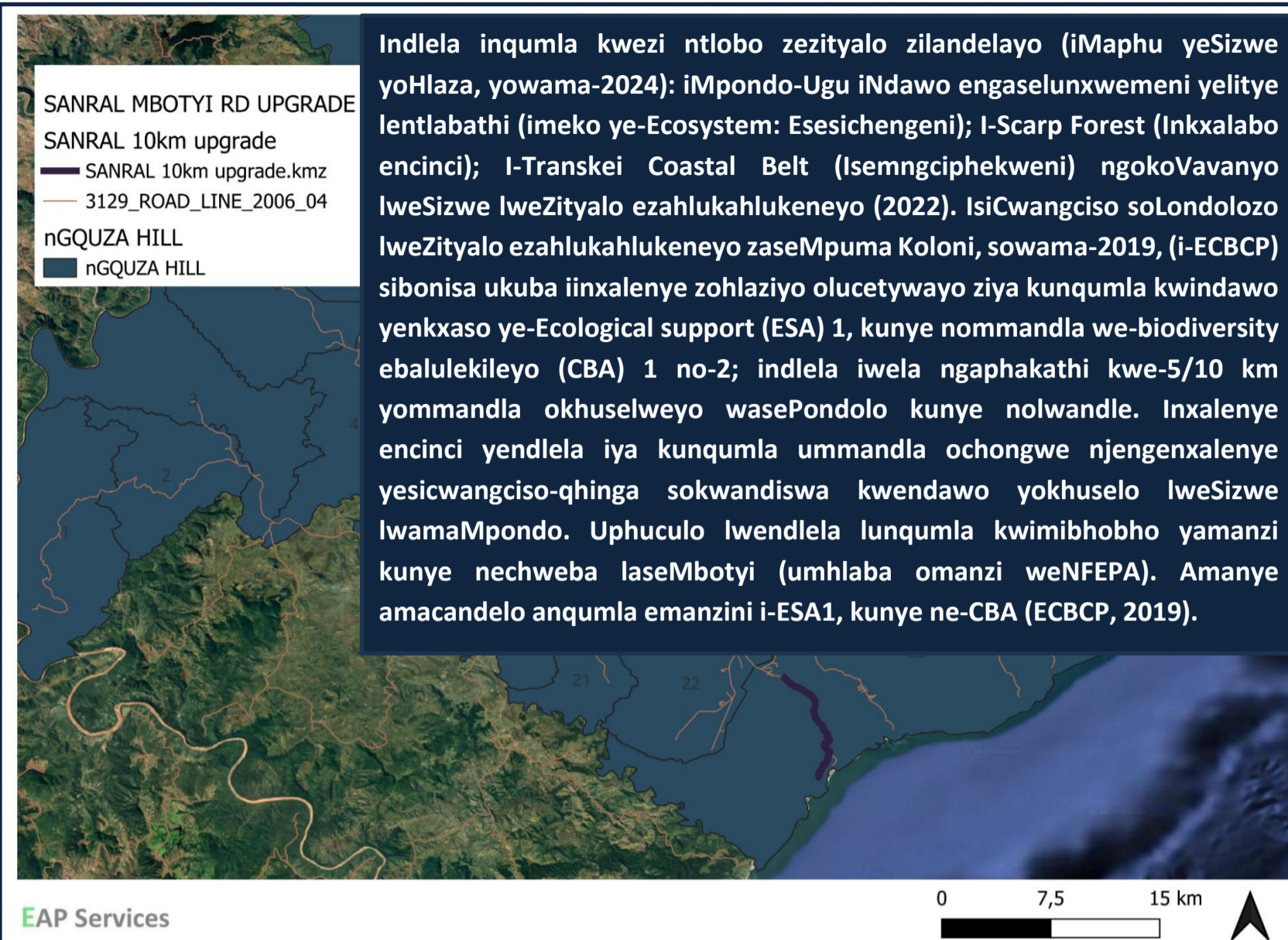

He is known for his high attention to tactical detail and work ethic, and as a coach who puts player improvement first.
